*Creating decent work opportunities for vulnerable people through infrastructure projects in Lebanon*

The International Labour Organization (ILO) is implementing the Employment Intensive Infrastructure Programme (EIIP), fully financed by the German government through KfW bank.

The programme aims at creating short- to mid-term employment opportunities for vulnerable people affected by the Syrian crises through infrastructure works that support the national authorities and municipalities throughout the country.

The program started in 2017, and is currently launching its 5<sup>th</sup> phase, with focus on road maintenance, municipal infrastructure and green plan works.
